Race Categories (CCC Rules and Regulations 331.1) based on Year of Birth

Race categories for licenses are based on the new Competition Model. Year of Birth and race distances will define race categories during the 2012 Competition season. Athletes:

Born in 1992 or after (are eligible for World Jr. Championships)
Born in 1989 or after (are eligible for World U23 Championships)

Fees and Application

Race license application fees are \$55.00 for skiers born in 1992 or after, and \$65.00 for skiers born in 1991 or before. These amounts include GST. To apply, please read the declaration and provide all required information. Cross Country Canada welcomes and appreciates any donations made to the National Ski Team programs. CCC will issue a charitable donation tax receipt for any donation of \$25.00 or more. Race license fees are not eligible for a charitable donation tax receipt.

Fees and donations may be paid by cheque (payable to *Cross Country Canada*) or by VISA or MasterCard.

Privacy

Information collected on the race license application form is used to properly identify registered race license holders throughout the 2012 Competition season. This information may be made available to race organizers/staff and/or to third parties as required to fulfill benefits conferred by this race license (for example, SkiTrax magazine subscription). CCC limits the disclosure of any information to that which is required to fulfill the purpose for which it is required. The athlete's signature indicates his/her consent to the collection, use and disclosure of this information at the discretion of CCC. For an individual who is a minor, consent may be obtained from a legal guardian or person having power of attorney.

Cross Country Canada is subject to the *Personal Information Protection and Electronic Documents Act*, which sets out principles of fair information practices that in turn form ground rules for the collection, use and disclosure of personal information. CCC adheres to the principles set out in document 1.13 CCC *Privacy Policy*. DECLARATION

In consideration of **Cross Country Canada** (hereinafter called **CCC**) enabling the undersigned competitor to train and compete according to **CCC** rules and regulations in force from time to time, in any and all ski areas and/or events which may be fully authorized and sanctioned by **CCC**, I hereby agree and declare as follows:

(i) That the sport of Cross Country Skiing has risks and inherent dangers that could cause me bodily injury, including death.

(ii) That my physical condition, to the best of my knowledge, is adequate to participate safely in the sport of cross country skiing.

(iii) That I will abide by all the Rules and Regulations as set forth by **CCC, FIS and IPC**.

(iv) That as a participant in CCC sanctioned sport and as a CCC race license holder I will participate in and be subject to the *Canadian Anti-Doping Program (CADP)* and document 1.10 *CCC Anti-Doping Policy*. I am fully aware of the doping violations and consequences rules set out in the *CADP*. I am fully aware of the penalties that will be imposed in the event of an anti-doping rule violation and I understand that refusal to submit to sample collection as required under the *CADP* is considered to be an anti-doping rule violation.
