**Race Categories (CCC Rules and Regulations 341.1) based on Year of Birth**

Race categories for licenses are based on the new Competition Model. Year of Birth and race distances will define race categories during the 2016 Competition season. Athletes:

- Born in 1998 or after** (are eligible for World Jr. Championships)
- Born in 1995 or after** (are eligible for World U23 Championships)

**Fees and Application**

The CCC Development License for the 2018 Competition season for skiers born in 2003 or after who wish to compete in Tier I or Tier II Nationally Sanctioned competitions will be \$25.

Race license application fees are \$55.00 for skiers born in 1998 - 2002, and \$65.00 for skiers born in 1997 or before. These amounts include GST. To apply, please read the declaration and provide all required information.

*Disclosure: Purchase of a CCC license entitles race performances to be tracked and included in the Canada Points List. CCC uses all efforts to include all sanctioned race results on the points list. However due to the increased number of Canadian racers competing outside of Canada, CCC cannot guarantee inclusion of results from FIS sanctioned competitions in the CPL. If sanctioned CCC or FIS race results do not appear on the most recent CPL, please inform CCC within 30 days of the publication of the Seeding or Selection list. CCC can't be held responsible for result omissions after this period.*

**Privacy**

Information collected on the race license application form is used to properly identify registered race license holders throughout the 2017/18 Competition season. This information may be made available to race organizers/staff and/or to third parties as required to fulfill benefits conferred by this race license. CCC limits the disclosure of any information to that which is required to fulfill the purpose for which it is required. The athlete's signature indicates his/her consent to the collection, use and disclosure of this information at the discretion of CCC. For an individual who is a minor, consent may be obtained from a legal guardian or person having power of attorney.

Cross Country Canada is subject to the *Personal Information Protection and Electronic Documents Act*, which sets out principles of fair information practices that in turn form ground rules for the collection, use and disclosure of personal information. CCC adheres to the principles set out in document 1.13 *CCC Privacy Policy*. **DECLARATION**

In consideration of **Cross Country Canada** (hereinafter called **CCC**) enabling the undersigned competitor to train and compete according to **CCC** rules and regulations in force from time to time, in any and all ski areas and/or events which may be fully authorized and sanctioned by **CCC**, I hereby agree and declare as follows:

*That as a participant in CCC sanctioned sport and as a CCC race license holder, I will participate in and be subject to the Canadian Anti-Doping Program (CADP) and document 1.10 CCC Anti-Doping Policy. CCC has adopted the 2009 CADP, which is the set of rules that govern doping control in Canada. Administered by the Canadian Centre for Ethics in Sport (CCES), the CADP applies to members of CCC and participants in CCC sanctioned activities. All members of CCC, whether in the role of athletes or athlete support personnel, are subject to the CADP. By signing below, I acknowledge that I am a member of CCC and I am aware that the CADP applies to me and I consent to its application to me. I am fully aware of the doping violations and consequences rules set out in the CADP. I am fully aware of the penalties that will be imposed in the event of an anti-doping rule violation and I understand that refusal to submit to sample collection as required under the CADP is considered to be an anti-doping rule violation.
